



On what exchange does Globalscape stock trade and what is its symbol?

Globalscape trades on the NYSE MKT stock exchange under the ticker symbol GSB.

When is Globalscape's fiscal year end?

Globalscape's fiscal year ends December 31.

When was Globalscape's initial public offering?

Globalscape was spun off from ATSI in September of 2000. At that time Globalscape became a separately listed company on the OTC exchange.

What is the number of shares outstanding?

As of March 31, 2017, the fully diluted share count was approximately 22.0 million diluted weighted shares outstanding.

Does Globalscape have a DRIP plan or a direct stock purchase plan?

Globalscape does not offer a dividend reinvestment program or a direct purchase plan for its common stock.

Does Globalscape issue cash dividends?

Globalscape initiated a quarterly dividend of \$0.015 per share of common stock beginning in the second quarter of fiscal 2015. The Company will announce record dates through public filings for its upcoming dividend payouts.

The board of directors also authorized special dividend payments of \$.07, \$.05 and \$0.05 to shareholders of record that were paid on December 27, 2012, December 3, 2013 and December 3, 2014 respectively. Announcements related to these special dividends can be found in the Company's filings with the Securities and Exchange Commission.

The Board of Directors declared a quarterly cash dividend of \$0.015 per share of common stock which was paid on March 8, 2017, to shareholders of record at the close of business at 5:00 pm Eastern Time on February 23, 2017. Dividends were paid each quarter last year.

We typically hold our annual meeting of stockholders in May or June at the Company's headquarters in San Antonio. The date and time will be made publicly available several weeks in advance of the meeting.

When does Globalscape announce its quarterly financial results?

The Company typically holds its quarterly earnings conference calls approximately one month after the close of its fiscal quarter. Globalscape will issue a press release announcing the date and time of the call one to two weeks before the call date.

Why doesn't the company provide guidance?

As discussed in our 10-K filing, a variety of risk factors could impact our operations and financial performance. While we have been very successful as a conservatively run company, we believe it is prudent to not set specific operational and financial expectations which can be affected by numerous factors outside of the company's control.

Who are Globalscape's auditors?

The Company uses BDO USA, LLP as its independent registered public accounting firm to audit the Company's financial statements.

When and where was Globalscape incorporated?

Globalscape was originally incorporated in Delaware in 1996.

How many employees does Globalscape have?

Included in the recent 10-K filing, as of December 31 2016, the Company had 133 employees.
