EFT Automation Jump-Start SOW

1 Goals

The goal of EFT Automation Jump-Start is to be a flexible, cost-effective service that will jumpstart/coach the customer on developing EFT Automation event rules.

The EFT Automation Jump-Start follows 3 phases for each automation Job:

• **Design and Analysis Phase:** The first phase of Jump-Start is to help your team make decisions about specific development tasks. We work with you to collaboratively examine business requirements and define a number of test cases for the job.

If you're starting from an existing automation, we will review the structure jobs/workflows and data structures in use and help you choose between reusing or refactoring workflows.

During the design and analysis phase, our team will provide you with the number of automation jobs and test cases that will be accommodated in the timeframe of the service. Your team can prioritize these appropriately and adjust as needed.

- **Training:** The second phase of Jump-Start is training for your EFT team. The training covers EFT event rules and advanced workflows that apply to your automation requirements. After training is complete, your team will have a working automation they can use as part of their project.
- **Build**: The third phase involves building and testing. Starting from a prototype, we mentor your team as they deploy the prototype into your environment to ensure functionality.

2 Deliverables

- Artifacts (documents, code, scripts, configuration, prototypes, deployment, and knowledge transfer) derived from the total days worked by the consultant or developer.
- Work days used by the Globalscape consultant or developer related to the in-scope activities instructed by the CUSTOMER during the engagement
